DIGITAL SIGNATURES...

Digital signatures are like electronic “fingerprints.” They are a specific type of electronic signature (e-signature). In the form of a coded message, the digital signature securely associates a signer with a document in a recorded transaction.

What is an example of a digital signature?

The most common example is a wet signature scanned by an electronic device and then inserted into a document. Another example of a simple digital signature is the email signature that we often add at the end of the email, and check the terms and conditions box in the software installation process. What are the steps of digital signature?

Steps to apply for a Digital Signature Certificate

- STEP 1:** Log on and select your type of entity. ...
- STEP 2:** Fill the necessary details. ...
- STEP 3:** Proof of identity and address. ...
- STEP 4:** Payment for DSC. ...
- STEP 5:** Post the documents required. ...

What are the three types of digital signatures?

The three types of electronic signatures are simple e-signatures (SEs), advanced e-signatures (AdESs), and qualified e-signatures (QESs).

Can we have 2 digital signatures?

However, an individual or



organization can obtain two digital signature certificates associated with a single e-mail address. You can also get an additional digital signature certificate for a different email account. It can be either for personal or professional use.

What is the main use of digital signature?

A digital signature is intended to solve the problem of tampering and impersonation in digital communications. Digital signatures can provide evidence of origin, identity and status of electronic documents, transactions, or digital messages. Signers can also use them to acknowledge informed consent.

Who can create digital signature?

A licensed Certifying Authority (CA) issues the digital signature. Certifying Authority (CA) means a person who has been granted a license to issue a digital signature certificate under Section 24 of the Indian IT-Act 2000.

What are the documents required for digital signature?

B. List of accepted documents - Indian Individual

- Aadhaar (eKYC Service), Passport. PAN Card. Driving

Licence. Post Office ID Card. Bank Account Passbook/statement containing the photograph and signed by an individual with attestation by the concerned Bank official.

● **What is the difference between signature and digital signature?**

An electronic signature is simply a legally valid electronic replacement of a handwritten signature. Digital signatures carry a user's information along with electronic signatures. Electronic signatures do not contain any authentication attached to them. A digital signature secures a document.

● **What are three 3 benefits of having a digital signature?**

The three main benefits of digital signature include increased contract speed, enhanced security, and lower transaction costs.

● **Is digital signature valid for all documents?**

Simply put, yes, digital signatures are valid and enforceable. If certain requirements are met, they have the same legal effect as their written equivalents. Like a traditionally signed contract, one of the most important elements of validity is the signing party's intent to be bound.

● **What is the law on digital signature?**

The IT Act allows the use of an electronic or digital signature for (i) filing any form, application, or document with any government authority; (ii) issue of any license, permit or approval by the government authority; and (iii)

receipt or payment of money in a particular manner, in electronic form.

● **What are the disadvantages of digital signature?**

The primary drawback of digital signatures is that they are limited to a single digital document. Each digital signature binds to a unique online document, hash algorithm, private key, and public key.

● **Can digital signature be misused?**

If private key is not stored securely, then it can be misused to sign an electronic record without the knowledge of the owner of the private key. In paper world, date, and the place where the paper has been signed is recorded and court proceedings are followed on that basis.

● **What is the future of digital signatures?**

Digital signatures will play an important role in the future of digital transformation. The market for e-signature solutions is expected to grow at a rate of 26.6% annually between 2021 and 2030, suggesting that this technology will be important to future digital transformations.

● **Can we cancel digital signature?**

A Digital Signature Certificate shall not be revoked unless the subscriber has been given an opportunity of being heard in the matter. On revocation of a Digital Signature Certificate under this section, the Certifying Authority shall communicate the same to the subscriber.

न्यायालयाच्या संदर्भात वकिलाचे वर्तन

न्यायालयासंदर्भात वकिलाचे वर्तन कसे असावे, ते आपण पहात होतो. मुक्त समाज, म्हणजे कोणत्याही दडपणाखाली नसलेला समाज टिकून राहायचा असेल तर न्याय व्यवस्थेची, न्यायालयाची प्रतिष्ठा राखली जाणे अत्यावश्यक आहे. हे लक्षात घेऊन वकिलाने न्यायालयाशी आदबीने वागले पाहिजे.

निकाल आपल्या बाजूने व्हावा म्हणून कोणत्याही बेकायदेशीर आणि अयोग्य मार्गाने वकिलाने न्यायालयावर दडपण आणू नये. तसेच चालू केसच्या संदर्भात न्यायालयाशी वैयक्तिक पातळीवर संपर्क साधू नये. गैरमार्गाने न्यायालयावर दडपण आणणे, हे व्यावसायिक गैरवर्तन समजले जाईल.

न्यायालयाच्या संदर्भात कोणत्याही प्रकारे आतताई वागण्यापासून स्वतःच्या अशिलाला परावृत्त करण्याचा प्रामाणिक आटोकाट प्रयत्न वकिलाने करावा, अशी अपेक्षा नीतीनियमात करण्यात आली आहे. न्यायालय, प्रतिपक्ष किंवा प्रतिपक्षाचा वकील यांच्या संदर्भात वकिलाने ज्या ज्या गोष्टी करू नयेत, असा दंडक आहे, त्या गोष्टी अशिलानेही करता कामा नयेत. समजा अशील अशा गोष्टी करितच राहिला तर वकिलाने याचे प्रतिनिधित्व करणे

थांबवले पाहिजे, म्हणजेच त्याचे वकीलपत्र रद्द केले पाहिजे. अशिलाचे 'मुखपत्र' असल्यासारखे वकिलाने वागू नये.

प्रत्येक वेळी न्यायालयापुढे येताना वकिलांसाठी ठरवून दिलेला गणवेश घालूनच वकिलाने आले पाहिजे. तो गणवेश आणि एकंदरचे वागणे-बोलणे नीटनेटके (प्रेझेंटेबल) असले पाहिजे.

न्यायालय, ट्रायब्युनल किंवा कोणतीही अॅथॉरिटी यांचा असलेला एकमेव सदस्य किंवा अनेक सदस्यांतील कोणताही एक सदस्य वकिलाशी (कोणत्याही प्रकारे) संबंधित असेल, नात्यातला असेल अशा ठिकाणी वकिलाने केस चालवू नये किंवा कोणत्याही कारणासाठी 'अॅपीअर' होऊ नये.

वकील हा कोर्टाचा अधिकारी असतो...

बार कौन्सिलच्या यादीवर वकील म्हणून ज्याचे नाव नोंदले गेले आहे, तो वकील, अॅडव्होकेट्स अॅक्टच्या तरतुदीच्या अधीन राहून, भारतातील कोणत्याही कोर्टात व्यवसाय करू शकतो, अगदी सुप्रीम कोर्टातसुद्धा.

वकिलाने फक्त कोर्टात असतानाच गणवेश घालावा, अन्य कोणत्याही सार्वजनिक ठिकाणी त्याचा वापर करू नये.

समजा एखादा वकील एखाद्या संस्थेच्या, संघटनेच्या, इन्स्टिट्यूटच्या किंवा कंपनीच्या कार्यकारी मंडळावर सदस्य असेल, तर अशा वकिलाने त्या संस्थेच्या, संघटनेच्या, कंपनीच्या बाजूने किंवा विरुद्ध 'ऑपिअर' होऊ नये. (वकिलपत्र दाखल करू नये.) मात्र, हा नियम बार कोन्सिल, बार असोसिएशन किंवा कंपनी म्हणून नोंदलेली लॉ सोसायटी यांना लागू नाही.

ज्या प्रकरणात एखाद्या वकिलाचे स्वतःचे आर्थिक हित गुंतले आहे, अशा प्रकरणात त्या वकिलाने काम पाहू नये. उदाहरणार्थ, नादारी किंवा दिवाळखोरी जाहीर करण्याच्या प्रकरणात एखादा वकील स्वतः मिळकतदार (क्रेडिटर) असेल तर त्याने कोणाच्याच बाजूने काम पाहू नये. वकील हा कोर्टाचा एक अधिकारी असतो. त्याच्या विधानांवर विश्वास ठेवून कोर्ट कृती करित असतो. म्हणून वकिलाने वस्तुस्थितीदर्शक विधाने अतिशय अचूक केली पाहिजेत. वस्तुस्थितीचा विपर्यास करता कामा नये. कोर्टाच्या न्यायादानाच्या कामात वकिलाने कोर्टाला साहाय्य केले पाहिजे. कोर्टापुढील प्रकरणांशी संबंधित वस्तुस्थिती लपवून कोर्टाची दिशाभूल करता कामा नये. समजा एका कोर्टाने एखादा अर्ज फेटाळला असेल, तर ही वस्तुस्थिती दडवून ठेवून जर तसाच अर्ज दुसऱ्या कोर्टापुढे सादर केला, तर ते व्यावसायिक गैरवर्तन ठरते. (अशा प्रकारची फसवणूक फक्त हायकोर्टाच्या बेंचचीच होऊ शकते.
