Landscaping refers to any activity that modifies the visible features of an area of land, including the following:

Living elements, such as flora or fauna; or what is commonly called gardening, the art and craft of growing plants with a goal of creating a beauty within the landscape.

Natural abiotic elements, such as landforms, terrain shape and elevation, or bodies of water.

Abstract elements, such as the weather and lighting conditions.

Landscaping requires a certain understanding of horticulture and artistic design, but is not limited to plants and horticulture. Sculpting land to enhance usability (patio, walkways, ponds, water features) are also examples of landscaping being used. When intended as purely an aesthetic change, the term Ornamental Landscaping is used.

Often, designers refer to landscaping as an extension of rooms in your house (each one has a function). Outdoor spaces have a vast amount of flexibility as far as materials and function. It is often

said the only limitation to outdoor space is one's imagination.

Understanding the land

Construction requires both study and observation, and the process varies in different parts of the world. Landscaping varies according to different regions. Therefore, normally local natural experts are recommended if it is done for the first Understanding of the site is one of the chief essentials for successful Different natural landscaping. features and phenomena, like the position of the Sun, terrain, topography, soil qualities, prevailing winds, depth of the frost line, and the system of native flora and fauna must be taken into account. Sometimes the land is not fit for landscaping. To landscape it, the land must be reshaped to direct water for appropriate drainage. This reshaping of land is called grading. Sometimes in large landscaping projects for example, parks, sports fields and reserves soil may need to be improved by adding nutrients for growth of plants or turf, this process is called soil amelioration.





Removal of earth from the land is called cutting while when earth is added to the slope, it is called filling. Sometimes the grading process may involve removal of excessive waste (landfills), soil and rocks, so designers should take into account while in the planning stage.

Additional information

At the start, the landscaping contractor issues a statement which is a rough design and layout of what could be done with the land to achieve the desired outcome. Landscaping has become more technological than natural, as few projects begin without bulldozers, lawnmowers, or chainsaws. Different areas have different qualities of plants. When growing new grass, it should ideally be done in the spring and the fall seasons to maximize growth and to minimize the spread of weeds. It is generally agreed that organic or chemical fertilizers are required for good plant growth. Some landscapers prefer to use mix gravel with rocks of varying sizes to add interest in large areas.

Aqua scaping is the craft of arranging aquatic plants, as well as rocks, stones, cave work, or driftwood, in an aesthetically pleasing manner within an aquarium—in effect, gardening under water. Aquascape designs include several distinct styles, including the garden-like Dutch style and the Japanese-inspired nature style. Typically, an aquascape houses fish as well as plants, although it is possible to create an aquascape with plants only, or with rockwork or other hardscape and no plants.

Aqua scaping appears to have begun to be a popular hobby in the 1930s in the Netherlands, following the introduction of the Dutch style aqua scaping techniques. With the increasing availability of mass-produced freshwater fishkeeping products and popularity of fishkeeping following the First World War, hobbyists began exploring the new possibilities of creating an aquarium that did not have fish as the main attraction

Although the primary aim of aqua scaping is to create an artful underwater landscape, the technical aspects of tank maintenance and the growth requirements of aquatic plants are also taken into consideration. Many factors must be balanced in the closed system of an aquarium tank to ensure the success of an aquascape. These factors include filtration, maintaining carbon dioxide at levels sufficient to support photosynthesis underwater, substrate and

fertilization, lighting, and algae control.

Aquascape hobbyists trade plants, conduct contests, and share photographs and information via the Internet. The United States-based Aquatic Gardeners Association has about 1,200 members.

Arboriculture is the cultivation, management, and study of individual trees, shrubs, vines, and other perennial woody plants. The science of arboriculture studies how these plants grow and respond to cultural practices and to their environment. The practice of arboriculture includes cultural techniques such as selection, planting, training, fertilization, pest and pathogen control, pruning, shaping, and removal.

Arboriculture is primarily focused on individual woody plants and trees maintained for permanent landscape and amenity purposes, usually in gardens, parks or other populated settings, by arborists, for the enjoyment, protection, and benefit of people.

Arboriculturally matters are also considered to be within the practice of urban forestry yet the clear and separate divisions are not distinct or discreet.

Eco scaping is a spatial planning discipline that integrates landscape architecture and environmental science to create sustainable designs or construction. The approach of Eco scaping is holistic and strives to respect the pre-existing materials, microenvironments, and structures (backyards, cities, campuses, etc.) in sustainable land use management with ecological balance.

While landscapes are continually evolving, and new ecosystems are constantly emerging, the concept of ecoscape thinking serves as a driving force for restoration efforts. It directs human attention, including our legal frameworks, toward our connection with the broader environment and our responsibility in preserving rapidly disappearing ecosystems.

Consequently, ecoscapes can adapt in size, expanding or contracting based on the level of commitment humans are willing to invest in restoring ecosystem functions. Overemphasizing ecological aspects rather than socio-ecological factors downplays the significance of governance in the success of large-scale restoration initiatives. This growing emphasis underscores the value of extensive landscapes and seascapes for communities, as they are managed with the objective of conserving nature, which, in turn, delivers economic, social, and ecological advantages.

यांच्यातील वाद, म्हणजे मालाचा किंवा सेवेचा दर्जा योग्य तसा नसणे, माल ठरलेल्या वेळेत न देणे, माल खराब किंवा शिळा असणे, हे वाद ग्राहक न्यायालयापुढे चालतात (दि. १८/८/२०१४). या न्यायालयाला जिल्हा ग्राहक न्याय मंच (डिस्ट्रिक्ट कन्झ्युमर फोरम) म्हणतात. येथील निर्णयाविरुद्ध राज्य ग्राहक न्याय मंच आणि त्यानंतर केंद्रिय ग्राहक न्याय मंचात दाद मागता येते. ग्राहकांना न्याय देण्यासाठी ग्राहक संरक्षण कायदा (कन्झ्युमर प्रोटेक्शन ॲक्ट) अस्तित्वात आहे. त्या आधारे मंचापुढील खटले चालतात.

सोडवण्यासाठी खास वेगळे कायदे करण्यात आले आहेत. त्यांना 'लेबर लॉज' म्हणतात. उदा. फॅक्टरी ॲक्ट, इंडिस्ट्रियल डिस्प्युट्स ॲक्ट, वर्कमेन्स कॉम्पेन्सेशन ॲक्ट, मिनिमम वेजेस ॲक्ट, बोनस ॲक्ट वगैरे. या कायद्यांच्या आधारे कामगार तंटे सोडवले जातात.

महसूलासंबंधीचे तंटे, जिमनीतून मिळणार्या नफ्यासंबंधीचे वाद, हे निर्णय महसूल न्यायालयात हाताळले जातात. (रेव्हेन्यू कोर्ट). जिल्हाधिकारी कार्यालयात वरिष्ठ सरकारी अधिकारी हे काम पाहतो. तेथील निवाड्यावर मंत्रालयात अपील करता येते. मंत्रीपातळीवर हे अपील चालते. येथेही समाधान झाले नाही तर उच्च न्यायालयात दाद मागता येते.

घटस्फोट, पोटगी, दत्तकविधान, पलकत्व यासंबंधीच्या कायदेशीर बाबींचा, तंट्यांचा कुटुंब न्यायालयात (फॅमिली कोर्ट) विचार केला जातो. मूल दत्तक घ्यायचे असेल किंवा मुलाचे पलकत्व (गार्डियनिशप) निश्चित करावयाचे असेल तर ही कामे कुटुंब न्यायालय करते. घटस्फोटाची प्रकरणे कुटुंब न्यायालयापुढे जाण्यापूर्वी त्या न्यायालयाच्या आवारातच असलेल्या सरकारी समुपदेशकांपुढे (कौन्सिलर्स) जातात. घटस्फोट टाळून समेट घडवून आणण्याचा प्रयत्न हे समुपदेशक करतात. त्यांना अपयश आले तर ते न्यायालयाला तसा अहवाल देतात. त्यांनंतर ते घटस्फोट प्रकरण न्यायालयापुढे सुनावणीस येते.

विविध न्यायालयांत लागलेल्या निकालांवर आपले समाधान झाले नाही तर आपण उच्च न्यायालयात दाद मागू शकतो. त्यानंतर सर्वोच्च न्यायालयातही अपील करता येते. प्रत्येक राज्याला किमान एक उच्च न्यायालय आणि संपूर्ण देशासाठी एक सर्वोच्च न्यायालय आहे. एकाच उच्च न्यायालयाच्या शाखा गरजेनुसार त्या-त्या राज्यांपुरत्या स्थापन केल्या जातात. महाराष्ट्रात मुंबई उच्च न्यायालयाच्या दोन शाखा आहेत. त्यांना नागपर खंडपीठ आणि औरंगाबाद खंडपीठ म्हणतात.

अपील चालवणे एवढेच उच्च वा सर्वोच्च न्यायालयाचे काम नाही. भारतीय राज्यघटनेने त्यांच्यावर मूलभूत हक्करक्षणाची मोलाची जबाबदारी टाकली आहे. राज्य घटनेने नागरिकांना दिलेल्या मूलभूत हक्कांची सरकारकडून पायमल्ली होत आहे असे वाटले तर नागरिक उच्च वा सर्वोच्च न्यायालयांत दाद मागू शकतो.

In case of tenant verification through online, it will be mandatory to provide a copy of the same by the house owner at the police station

Taking heavy deposit is not legal under Maharashtra Rent Act 1999.
