

E-REGISTRATION OF LEAVE AND LICENCE MAY TOUCH 10L-MARK

E-Registration numbers of leave and licence agreements are likely to touch the 10-lakh mark for the first time this year.

A property registration department official said till August-end, 6.3 lakh leave and licence agreements have been eregistered in the state with Pune, Mumbai and Thane achieving the top slots.

State inspector general of registration and stamps (IGR) Shravan Hardikar said that the eregistration of leave and licence agreements had been steadily picking up over the years. In 2022, the numbers may for the first time touch the 10-lakh mark.

The e-registration facility was introduced to allow citizens to carry out leave and licence agreement registration from the comfort of home, instead of visiting the sub-registrar. Ir was facilitated around six years ago.

Districts such as Pune. Mumbai and Thane have recorded the maximum number of eregistration of leave and licence documents as the data shows of the registration department. of the total 6.3 lakh documents registered till the end of August, Pune's share was 2.39 lakh, followed by Mumbai (1.85 lakh) and Thane (1.66 lakh). The three districts had registered the highest number of agreements last year too. The total leave and licence agreements registered in 2021 were 7.7 lakh.

Rural areas of the state are still lagging in terms of E-

registrations of the agreements. Districts such as Gadchiroli have registered only one agreement as against six last year. The corresponding figures for Hingoli were eight and five, respectively.

Citizens are finding the eregistration process easy, as they don't have to visit the subregistrar office (SRO). In eregistration, citizens prepare their documents online using online templates provided by the department and make payment of stamp duty and registration fee, online.

"The process for the leave and licence registrations has been simplified and people are no longer hesitating to register their rental agreements: said Amitabh Mehta, a lawyer.

Association of Real Estate Agents representative Sachin Shinghavi, however, expressed concerns over the frequent technical glitches in the system. "The rental agreements are done on an inter-city and inter-district basis. But the servers often develop snags," he said.

Online police verification process delayed

The online police verification for tenants across the state may be delayed by one more month, as the registration department is yet to get the data for mapping 1,130 police stations across the state.



UPI is a single platform that merges various banking services and features under one umbrella. A UPI ID and PIN are sufficient to send and receive money. Real-time bank-to-bank payments can be made using a mobile number or virtual payment address (UPI ID). The pilot launch was started on 11th April 2016 by Dr. Raghuram G Rajan, Governor, RBI at Mumbai.

Unified Payments Interface is an instant real-time payment system developed by National Payments Corporation of India. The interface facilitates interbank peer-to-peer and person-to-merchant transactions. It is used on mobile devices to instantly transfer funds between two bank accounts.

Is UPI government or private?

It is regulated by the Reserve Bank of India (RBI) and works by instantly transferring funds between two bank accounts on a mobile platform.

What is the process of UPI?

UPI is a digital platform that helps you transfer funds from one bank account to another without using any account number, bank name, account type or IFSC. To use UPI to transfer funds, you need to have the following things in place: A bank account. An active mobile number (linked to your bank account)

What is the function of UPI?

Unified Payments Interface (UPI) is a payment system that allows users to link more than one bank account in a single smartphone app and make fund transfers without having to provide IFSC code or account number. This is a real-time payment system where funds are credited instantly on a real-time basis.

What is UPI?

Who is the founder of UPI?

Unified Payment Interface (UPI) was developed by the National Payments Corporation of India (NPCI) which was established by the Reserve Bank of India (RBI) and Indian Banks Association (IBA).

Which is the first UPI app?

BHIM (Bharat Interface for Money) is an Indian mobile payment app developed by the National Payments Corporation of India (NPCI), based on the Unified Payments Interface (UPI).

Is Google Pay is UPI?

In relation to UPI Payment Transactions, Google Pay is a TPAP authorised by NPCI to facilitate Payment Transactions through HDFC Bank, Axis Bank, ICICI Bank and State Bank of India. We are a service provider and participate in UPI through PSP Banks.

Is UPI and Paytm same?

Paytm, the most popular digital wallet in India, has now integrated with the BHIM UPI platform. Users will be able to create their own Paytm BHIM UPI ID through the app and link their savings bank account to send and receive money.

Is UPI payment safe?

UPI uses a highly secured platform. The users have to first register into UPI using the same mobile number already registered with the bank. Despite the secured platform, still, there are chances of fraud if you are not careful when using the UPI for transactions.

How many countries use Indian UPI?

Addressing Digital India Week, IT Minister Ashwini Vaishnaw has stated that India is in talks with 30 countries for UPI and three countries have already signed memorandums of understanding (MoUs) in this regard.


